### **Outpatient polyclinic care:**

- initial, repeated treatment of the Insured for urgent indications to specialist doctors: therapist, surgeon, gynecologist, urologist, traumatologist, neurologist, otolaryngologist, ophthalmologist;
- instrumental diagnostics: X-ray, ultrasound, functional diagnostics (ECG);
- laboratory research methods: general clinical, biochemical;
- examination of temporary disability (issuance of a sick leave)
- minor surgical and traumatological interventions and manipulations performed for urgent indications on an outpatient basis, including the cost of dressings and plaster fixing dressings.

### **Dental services for acute toothache:**

- Surgical dentistry (extraction of teeth for medical reasons, opening and drainage of abscesses of the oral cavity)
- Anesthetic manipulations (anesthesia: application, infiltration, conduction).
- Diagnostic methods – radiography.

**Emergency inpatient care:** stay in a multi-bed ward in a hospital, treatment and supervision by the attending physician in the department, surgical interventions, intensive care unit.

### **The procedure for providing medical care:**

1. The Insured must contact by phone 0530 in order to receive the services provided by this medical program.
2. The responsible person of the Institution requests a letter of guarantee from the Customer for hospitalization upon identification of a situation requiring emergency inpatient care to the insured person.
3. The Insured must contact the Regional Dental Clinic on Bolshaya Pokrovskaya str. by phone (831) 433-23-27 and make an appointment and/or appear at the address: Nizhny Novgorod, Bolshaya Pokrovskaya str., 23 to receive dental services.
